

Camco Corporate Services Limited (RTA) . The e-mails were sent to Members whose names appeared on the Register of Members/list of beneficial owners provided by the Depositories as on February 24, 2023 and whose E-mail ids were registered with the Company/Depository participants. As confirmed by RTA/Company, Notices were sent to 78912 Shareholders, and 3273 email were bounced. Members were given the option to vote electronically on the e-voting platform, provided by Central Depository Services Limited (CDSL), to enable them to cast their votes electronically. The required paper advertisement with respect to other shareholders, inter alia, by way of seeking updation of mail ids to a dedicated email id/ online process had been given in Makkal Kural (Tamilnadu Edition) and Business Standard (All India Edition) on 15th February 2023. 1.2 The Company had given Public Advertisement, with respect to completion of dispatch of Notice of postal ballot, which was published on March 1, 2023 in "Business Standard" (All India Edition) & in "Makkal Kural" (Tamilnadu Edition) on the same date. In this Public Advertisement, Members were informed about the availability of the Notice in the Websites of the Company, CDSL and the Stock Exchanges and the facility to write to the Cameo Corporate Services Limited (RTA) to get a copy through E-mail. In terms of the Notice, the E-voting commenced on 1st March 2023 (9:00 AM 1.3 IST) and ends on 30th March 2023 (5:00 PM IST). 1.4 Particulars of all the votes cast electronically have been entered in a register separately maintained for the purpose. 1.5 RTA has confirmed that votes cast by e voting matched with the Register of Members of the company/ list of beneficiaries. 1.6 All votes cast through e-voting upto 5.00 PM on March 30, 2023, the last date and time fixed by the Company for postal ballot through E-voting, were considered for our scrutiny. 1.7 Corporate members who have cast their votes without Board resolutions were invalidated.
