The e-mails were sent to Members whose names appeared on the Register of Members/list of beneficial owners provided by the Depositories as on February 24, 2023 and whose E-mail ids were registered with the Company/Depository participants. As confirmed by RTA/Company, Notices were sent to 78912 Shareholders, and 3273 email were bounced. Members were given the option to vote electronically on the e-voting platform, provided by Central Depository Services Limited (CDSL), to enable them to cast their votes electronically. The required paper advertisement with respect to other shareholders, inter alia, by way of seeking updation of mail ids to a dedicated email id/ online process had been given in Makkal Kural (Tamilnadu Edition) and Business Standard (All India Edition) on 15th February 2023.
